## KNOW ALL MEN BY THESE PRESENT:

This service contract made into by and between the **DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE I** with office and postal address at <u>Aguila Road, Sevilla, City of San</u> <u>Fernando/, La Union</u>, and herein represented by its RTD for Research and Regulations, <u>JOVITA</u> <u>M. DATUIN, Ph. D.</u> and herein after referred to as the "FIRST PARTY"; and

The LORD ANGEL CANTEEN & STORE with address at Dagupan City, Pangasinan represented by ANGELINE M. DOMALANTA herein after called the "SECOND PARTY" COMMISSION ON AUDIT

That the above mentioned parties bind themselves and mutually agree to abide the following terms and condition of the SERVICE CONTRACT to wit:

## That the FIRST PARTY shall responsible for the:

- 1.
