## BAC Resolution No. <u>2020-04-113</u> Series of 2020

## TITLE OF THE PROJECT: Supply and delivery of various Cell Cards to be used in monitoring and reporting in support to the implementation of Rice Resiliency Project

## APPROVED BUDGET FOR THE CONTRACT: Php499,950.00

WHEREAS, the **Rice Banner Program** (hereinafter referred to as end-user) has submitted a duly approved Purchase Request for the **Supply and delivery of various Cell Cards to be used in monitoring and reporting in support to the implementation of Rice Resiliency Project** with an Approved Budget for the Contract (ABC) of **Php499,950.00** with reference to National Rice Program, FY 2020 GAA RA 11465, ESETS;

WHEREAS, pursuant to Section 20.2 of the 2016 Revised Implementing Rules and Regulations of RA 9184 stipulating thereon the non-mandatory nature of the conduct of a Pre-Procurement Conference (PPC) for small procurements, a Pre-Procurement Conference (PPC) was not conducted for the purpose;

WHEREAS, by virtue of the approved Annual Procurement Plan (APP) of this Procuring Entity and Project Procurement Management Plan (PPMP) of the end-user, hereto attached as Annexes "A" and "B", the BAC resorted to SHOPPING Mode of Procurement;

WHEREAS, resorting to **SHOPPING PROCUREMENT** is sanctioned by the provisions of the 2016 Revised Implementing Rules and Regulations of RA 9184, particularly Section 52.1, Item b thereof;

WHEREAS, subject to the following conditions, the SHOPPING Mode of Procurement may be resorted to, to wit:

- a. the amount of the items to be procured does not exceed P1,000,000.00 as provided for in Annex "H" of the Revised IRR of RA 9184;
- b. the items to be procured are readily available off-the-shelf goods or ordinary office supplies or equipment;
- c. the items to be procured are not available at the Procurement Service-Department of Budget and Management (PS-DBM);
- d. resorting to shopping procurement will not result to splitting of contracts;
- e. at least three (3) price quotations shall be obtained from bonafide suppliers.

WHEREAS, the BAC Secretariat has posted at the PhilGEPS (*Reference Number 7011712*), DA Website and conspicuous places of DA-RFO I premises the Notice of Procurement (viz, Shopping);

WHEREAS, the BAC delegated to the End-User the serving of the Request For Quotation (RFQ) to at least three (3) bonafide suppliers of known qualification in consonance to **Section 52.1 Item b in relation to Annex "H"** (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, thus, as a result of which the hereunder named suppliers have submitted their proposals/quotations:

- 1. Masangkay Computer Center;
- 2. Thunder General Merchandize;
- 3. PC4Me One-Stop Computer Corp.;

WHEREAS, the proposals/quotations of the above-mentioned suppliers were received and evaluated by the concerned Technical Working Group (TWG), and hereunder presented as follows:

WHEREAS, from the results of the evaluation conducted by the concerned Technical Working Group, and with the assistance of the end-user, it shows that **Masangkay Computer Center** has offered the lowest calculated quotation in comparison to the offers of *Thunder General Merchandize and PC4Me One-Stop Computer Corp.;* 

WHEREAS, the BAC, upon careful examination, validation and verification of the bid/price quotation submitted by **Masangkay Computer Center** and particularly noting the evaluation of the concerned TWG as appearing in the abstract of quotation/bids, has found that the quotation of **Masangkay Computer Center** is the lowest calculated and responsive quotation and that, its quotation is deemed acceptable, proper and most advantageous to the government, hence, the same is eligible for award;

WHEREAS, apart from the quotation of the bidder having been declared as the Lowest Calculated and Responsive Quotation, the eligibility documents submitted as required by the provisions of the 2016 Revised Implementing Rules and Regulations of RA 9184 was likewise found to be complete and an updated copy thereof;

NOW THEREFORE, WE the Members of Bids and awards Committee, hereby RESOLVE as it is hereby RESOLVED-

- (a) To recommend for approval by the Regional Technical Director (RTD) concerned as per GMO # 1 Series of 2018 dated October 25, 2018 to award, by way of <u>SHOPPING PROCUREMENT</u> as provided for under Section 52.1 Item b in relation to Annex "H" (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, to Masangkay Computer Center as the bidder with the Lowest Calculated and Responsive Quotation to supply and deliver various Cell Cards to be used in monitoring and reporting in support to the implementation of Rice Resiliency Project with a total cost of Php454,500.00;
- (b) To post the Notice of Award in the PhilGEPS website, website of the Procuring Entity and at the conspicuous places reserved for this purpose in the premises of the Procuring Entity;
