SERVICE CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This service contract made and entered into by and between the DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 1 with office business and postal address at Aguila Rd., Sevilla, City of San Fernando, La Union herein represented by its Regional Technical Director for Operations DENNIS I. TACTAC, ABE and herein after referred to as the "FIRST PARTY":

CSI WAREHOUSE CLUB INC. with business and postal address at Biday, San Fernando City, La Union herein represented by CLAIRE ROSE BELO in her capacity as authorized representative herein after called the "SECOND PARTY."

The SECOND PARTY has agreed to provide Stall Rental/kiosk (4sqm) to the FIRST PARTY on the terms and conditions set out in the Agreement, while the latter has established based on eligibility documents and pursuant to the provisions of RA 9184 and its IRR that the former has the proper and necessary qualifications to provide the required services.

Therefore, in consideration of the matters described above, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Scope of Work/Obligations:

The FIRST PARTY shall:

- 1. Pay the Stall Rental/kiosk (4sqm) to be provided by the SECOND PARTY for **Promotion** of agri-fishery products through institutionalization/operationalization of KADIWA ni Ani at Kita Program on April to December 31, 2025 for a total contract price of Two Hundred Twenty-Five Thousand Pesos Only (Php225,000.00)
- 2. Notify the Second Party through official correspondences duly signed by the representative of the End-user on the exact date/s of the activity at least five (5) working days before the conduct of such activity.
- 3. Facilitate the payment for the booth rental within thirty (30) working days after the service is rendered.









The SECOND PARTY shall:

- 1. Provide Stall Rental/kiosk (4sqm) for the month of April to December 31, 2025 at CSI The City Mall, Biday, San Fernando City, La Union in accordance with its submitted quotation;
- 2. Observe the prescribed hours when the Stall Rental/kiosk (4sqm) shall be operated and provide adequate personnel to render said services;
- 3. Acknowledge the notification on the exact date/s of the activity sent by the representative of the End-user within three (3) working day/s from receipt thereof.

Other conditions:

1. Any modifications or amendments to this Agreement will be binding if evidenced in writing signed by each party and made at least seven (7) working days before the conduct of the activity.
