WHEREAS, the **Planning, Monitoring and Evaluation Division (PMED)** (hereinafter referred to as end-user) has submitted a duly approved Purchase Request and a Justification (attached as **Annex "A"**) for the procurement, **Provision of Meals, Snacks and Accommodation to be utilized and served during the conduct of Benchmarking Activity of Province-led Agriculture and Fisheries Extension System (PAFES)** with an Approved Budget for the Contract of **Two Hundred Forty Thousand Pesos (PhP240,000.00)** with reference to STO-PMED, LFP-CRA GAA FY 2024 RA 11975 CONT. APPROP.;

WHEREAS, by virtue of the approved Annual Procurement Plan (APP) of this Procuring Entity and Project Procurement Management Plan (PPMP) of the end-user, hereto attached as **Annexes "B" and "C"**, the BAC resorted to **NEGOTIATED PROCUREMENT THROUGH AGENCY TO AGENCY**;

WHEREAS, resort to Negotiated Procurement through **AGENCY TO AGENCY** is sanctioned by the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, particularly 53.5 in relation to Annex "H" thereof;

WHEREAS, based on the justification of the end-user that procurement from another agency of the government is more efficient and economical for the government and subject to the following conditions, Negotiated Procurement under Agency to Agency may be resorted to, to wit:

1. Servicing Agency has the mandate to deliver the goods and services required to be procured;
2. Servicing Agency has the absorptive capacity to undertake the project;
3. Servicing Agency owns or has access to the necessary tools and equipment required for the project;

WHEREAS, the **TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY-MOUNT DATA HOTEL (TIEZA-MDH)**, with office address at **Sinto, Bauko, Mountain Province**, signified its intention, through a Request for Quotation for the **Provision of Meals, Snacks and Accommodation to be utilized and served during the conduct of Benchmarking Activity of Province-led Agriculture and Fisheries Extension System (PAFES)** in the amount of **Two Hundred Forty Thousand Pesos (PhP240,000.00)**. A copy of its Quotation is hereto attached as **Annex "D"**.

WHEREAS, the **TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY-MOUNT DATA HOTEL (TIEZA-MDH)**, likewise, issued a Certification in compliance with the foregoing conditions, further detailed as follows:

This is to certify that **TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY-MOUNT DATA HOTEL (TIEZA-MDH)**, with office address at **Sinto, Bauko, Mountain Province**, complies with following conditions:

- *Has the mandate to serve meals and snacks and to provide accommodation;*
- *Has access to the necessary facilities, tools and equipment;*
- *Has the absorptive capacity to undertake the project/s;*

WHEREAS, posting of the Request for Quotation for Negotiated Procurement (**Agency-to-Agency Agreement**), as one of the Alternative Methods of Procurement, is not a requirement in view of Item IV. E of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184; however, for purposes of transparency, the Notice of Award of the procurement must be posted in the PhilGEPS website, DA-RFO 1 website and at conspicuous places of DA RFO I;

WHEREAS, upon determination, verification and evaluation of the foregoing circumstances and pursuant to the certification (attached as Annex "E") of the end-user unit that entering into Agency to Agency Agreement with TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY-MOUNT DATA HOTEL (TIEZA-MDH), is more efficient and economical to the government, the BAC has found that TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY-MOUNT DATA HOTEL (TIEZA-MDH), is eligible for the award of Contract of the subject procurement;

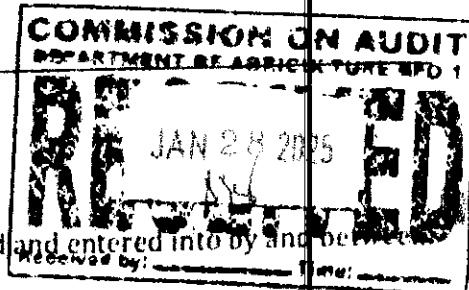

KNOW ALL PERSONS BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT (MOA) is executed and entered into by and between

The DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE 1, herein referred to as "DA RFO 1", a national government agency duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at Aguila Road, Sevilla Norte, San Fernando City, La Union, and herein represented by DENNIS I. TACTAC, ABE in his capacity as Regional Technical Director for Operations;

The TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY-MOUNT DATA HOTEL (TIEZA-MDH), herein referred to as "TIEZA-MDH" a national government agency duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at Sinto, Bauko, Mountain Province and herein represented by MS. ELLEONOR G. GULANGAN in her capacity as OIC-Resident Manager at TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY-MOUNT DATA HOTEL (TIEZA-MDH);

WITNESSETH: THAT -

WHEREAS, DA-RO 1 needs the services of the Servicing Agency, TIEZA-MDH, for the PROVISION OF MEALS, SNACKS AND ACCOMMODATION TO BE UTILIZED AND SERVED DURING THE CONDUCT OF BENCHMARKING ACTIVITY OF PROVINCE-LED AGRICULTURE AND FISHERIES EXTENSION SYSTEM (PAFES) (the "Project").

WHEREAS, the "TIEZA-MDH" is an agency of the government that serves meals, snacks and provides room accommodation services that is more beneficial and economical to the government.

WHEREAS, the end-user, the PMED, recommended and manifested compliance with the conditions provided in the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184 particularly 5.3.5 in relation to its Annex "H";

WHEREAS, the OIC, Regional Executive Director approved the Resolution of the Bids and Awards Committee (BAC), hereto attached as Annex "A", recommending the resort to Negotiated Procurement under Agency-to-Agency as reflected in the PPMP of the end-user and APP of the agency and award to "TIEZA-MDH" the provision of meals, snacks and accommodation.

WHEREAS, the "TIEZA-MDH" is willing to provide the foregoing service in conformity with the Notice of Award and the schedule of service as the end-user deems it exigent.

I. Coverage of this MOA:

This MOA pertains to the Negotiated Procurement (Agency-to-Agency Agreement) entered into by and between the herein mentioned parties for the **PROVISION OF MEALS, SNACKS AND ACCOMMODATION TO BE UTILIZED AND SERVED DURING THE CONDUCT OF BENCHMARKING ACTIVITY OF PROVINCE-LED AGRICULTURE AND FISHERIES EXTENSION SYSTEM (PAFES).**

II. Obligations of the Parties:

A. The "DA - RFO 1" shall:

1. allocate fund for the provision of meals, snacks and accommodation to be served during the Corn Cluster Development Plan Formulation Training with a **Total Contract Price of Two Hundred Forty Thousand Pesos (Php240,000.00)**
2. give "TIEZA-MDH" the corresponding amount of payment for meals, snacks and accommodation based on the schedule of requirements as may be established by the end-user;
3. require "TIEZA-MDH" to serve meals, snacks and provide accommodation;

B. The "TIEZA-MDH" shall:

1. Provide meals, snacks and accommodation to be utilized and served during the conduct of Benchmarking Activity of Province-led Agriculture and Fisheries Extension System (PAFES) on JANUARY 30 - FEB 1, 2025

III. Other Covenants:

Filing of copies of this MOA:

There shall be three (3) original copies of this MOA to be duly signed by both parties. The MOA facilitators/coordinators shall respectively file an original copy of this MOA. The concerned records custodian of both parties shall also be enjoined to file an original copy.

Venue of action:


In case of dispute/disagreement arising from this contract, the venue for the resolution of the same shall only be in the appropriate court of City of San Fernando, La Union;




Any modification/amendment/addendum to this MOA shall be mutually agreed upon in writing by all parties.


IV. Separability Clause:


If any stipulation in this MOA is declared invalid by a competent court, the other provisions not affected thereby shall remain valid and subsisting.




