Glossary of Terms, Abbreviations, and Acronyms

ABC –Approved Budget for the Contract.

ARCC – Allowable Range of Contract Cost.

BAC – Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR – Bureau of Internal Revenue.

BSP – Bangko Sentral ng Pilipinas.

CDA – Cooperative Development Authority.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

Contractor – is a natural or juridical entity whose proposal was accepted by the Procuring Entity and to whom the Contract to execute the Work was awarded. Contractor as used in these Bidding Documents may likewise refer to a supplier, distributor, manufacturer, or consultant.

CPI – Consumer Price Index.

DOLE – Department of Labor and Employment.

DTI – Department of Trade and Industry.

Foreign-funded Procurement or Foreign-Assisted Project —Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

GFI – Government Financial Institution

GOCC –Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term "related" or "analogous services" shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

Infrastructure Projects – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Completion of the Works is within <u>one hundred (100) calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Prospective bidders may obtain further information from and inspect the Bidding Documents at the address given below during **office hours** at **8:00 AM** to **5:00 PM**, **Monday to Friday**.

- 5. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
- 6. The **DA-RFO 1** will hold a Pre-Bid Conference on **29 July 2025, 2:00 PM** at DA-RFO 1, 5th Floor Conference Room, Aguila Road, Sevilla, City of San Fernando, La Union, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated above on or before 11 August 2025, 2:00 PM. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. **Bid opening** shall be on **11 August 2025, 2:00 PM** at DA-RFO 1, 5th Floor Conference Room, Aguila Road, Sevilla, City of San Fernando, La Union. Bids will be opened in the presence of the bidders or their authorized representatives.

10. ADDITIONAL INSTRUCTIONS TO BIDDERS:

- a. The bidders or their duly authorized representatives may attend the bid opening;
- b. In case a representative will be attending the Bid Opening, a Special Power of Attorney (SPA), Secretary's Certificate, Board Resolution or any other forms of authorization (notarized), as the case may be, together with the Companyissued Identification Card or any valid ID must be presented upon submission of the bid proposal at the BAC Secretariat. The name/title of the project must be indicated in the authorization or SPA.
- c. Each Bidder shall submit one copy of the first and second components of its Bid. Bidders shall submit their bids with proper index tabbing using the forms specified in the Bidding Documents in two (2) separate sealed bid envelopes, and which shall be submitted simultaneously:

The second component being the Financial requirements may be soft-bound/fastened in a folder, marked with the name of the contract and its IB No., name and address of the bidder, and enclosed in an envelope, sealed with signature and marked with the name and address of the bidder, addressed to the BIDS AND AWARDS COMMITTEE (BAC) DA RFO-1 CITY OF SAN FERNANDO, LA UNION, the specific Identification No. and the warning <a href="mailto:" "DO NOT OPEN BEFORE..." the date and time for the bid opening.

The Technical and Financial Requirement each in separate envelopes, shall be enclosed in a mother envelope with the same sealing and markings.

Non-compliance with index tabbings shall not be a ground for outright disqualification or declaration of ineligibility. The improper index tabbings must be duly acknowledged by the bidder/representative and be subject to the bid evaluation and post-qualification of the Technical Working Group (TWG) as to their substance.

- d. All documents in the Financial Requirements envelope must be duly signed and/or initialed, as needed, by the bidder/authorized representative on EACH AND EVERY PAGE thereof.

The **DA-RFO 1** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and Section 41 of the 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders

Section II. Instructions to Bidders

1. Scope of Bid

The Procuring Entity, **Department of Agriculture - Regional Field Office 1 (DA-RFO 1)** invites Bids for the **PROVISION OF LABOR, MATERIALS, EQUIPMENT RENTAL AND OTHER INCIDENTALS NEEDED FOR THE CONSTRUCTION OF STORAGE FACILITY FOR VERMI-PRODUCTS IN BRGY. LUBNAC, VINTAR, ILOCOS NORTE with Project Identification Number DA-RFO 1-2025-INFRA-042.**

The Procurement Project (referred to herein as "Project") is for the construction of Works, as described in Section VI (Specifications).

2. Funding Information

2.1. The GOP through the source of funding as indicated below for GAA FY 2025 in the amount of One Million One Hundred Twenty-Eight Thousand Five Hundred Sixty Pesos and Sixty-One Centavos (PhP1,128,560.61).

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manual and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or invitation to bid by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have inspected the site, determined the general characteristics of the contracted Works and the conditions for this Project, such as the location and the nature of the work; (b) climatic conditions; (c) transportation facilities; (c) nature and condition of the terrain, geological conditions at the site communication facilities, requirements, location and availability of construction aggregates and other materials, labor, water, electric power and access roads; and (d) other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, Coercive, and Obstructive Practices

The Procuring Entity, as well as the Bidders and Contractors, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. The Bidder must have an experience of having completed a Single Largest Completed Contract (SLCC) that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC adjusted, if necessary, by the Bidder to current prices using the PSA's CPI, except under conditions provided for in Section 23.4.2.4 of the 2016 revised IRR of RA No. 9184.

A contract is considered to be "similar" to the contract to be bid if it has the major categories of work stated in the **BDS**.

- 5.3. For Foreign-funded Procurement, the Procuring Entity and the foreign government/foreign or international financing institution may agree on another track record requirement, as specified in the Bidding Document prepared for this purpose.
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.2 of the 2016 IRR of RA No. 9184.

6. Origin of Associated Goods

There is no restriction on the origin of Goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN.

7. Subcontracts

7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than fifty percent (50%) of the Project.

The Procuring Entity has prescribed that subcontracting is not allowed:

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address,5th Floor Conference Room, Aguila Road, Sevilla, City of San Fernando, La Union indicated in paragraph 6 of the IB.

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents Comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in Section IX. Checklist of Technical and Financial Documents.
- 10.2. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. For Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.
- 10.3. A valid PCAB License is required, and in case of joint ventures, a valid special PCAB License, and registration for the type and cost of the contract for this Project. Any additional type of Contractor license or permit shall be indicated in the **BDS**.
- 10.4. A List of Contractor's key personnel (e.g., Project Manager, Project Engineers, Materials Engineers, and Foremen) assigned to the contract to be bid, with their complete qualification and experience data shall be provided. These key personnel must meet the required minimum years of experience set in the **BDS**.
- 10.5. A List of Contractor's major equipment units, which are owned, leased, and/or under purchase agreements, supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, must meet the minimum requirements for the contract set in the BDS.

11. Documents Comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section IX. Checklist of Technical and Financial Documents**.
- 11.2. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.3. For Foreign-funded procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

12. Alternative Bids

Bidders shall submit offers that comply with the requirements of the Bidding Documents, including the basic technical design as indicated in the drawings and specifications. Unless there is a value engineering clause in the **BDS**, alternative Bids shall not be accepted.

13. Bid Prices

All bid prices for the given scope of work in the Project as awarded shall be considered as fixed prices, and therefore not subject to price escalation during contract implementation, except under extraordinary circumstances as determined by the NEDA and approved by the GPPB pursuant to the revised Guidelines for Contract Price Escalation guidelines.

14. Bid and Payment Currencies

- 14.1. Bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.
- 14.2. Payment of the contract price shall be made in:
 - a. Philippine Pesos.

15. Bid Security

- 15.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.
- 15.2. The Bid and bid security shall be valid until **December 9, 2025.** Any bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

16. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission to the given website or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be

opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

17. Deadline for Submission of Bids

The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.

18. Opening and Preliminary Examination of Bids

18.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

18.2. The preliminary examination of Bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring Entity's BAC shall immediately conduct a detailed evaluation of all Bids rated "passed" using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of 2016 revised IRR of RA No. 9184.
- 19.2. If the Project allows partial bids, all Bids and combinations of Bids as indicated in the **BDS** shall be received by the same deadline and opened and evaluated simultaneously so as to determine the Bid or combination of Bids offering the lowest calculated cost to the Procuring Entity. Bid Security as required by **ITB** Clause 15 shall be submitted for each contract (lot) separately.
- 19.3. In all cases, the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184 must be sufficient for the total of the ABCs for all the lots participated in by the prospective Bidder.

20. Post Qualification

Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS), and other appropriate licenses and permits required by law and stated in the **BDS**.

21. Signing of the Contract

The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.

Section IV. General Conditions of Contract

1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

2. Sectional Completion of Works

If sectional completion is specified in the **Special Conditions of Contract (SCC)**, references in the Conditions of Contract to the Works, the Completion Date, and the Intended Completion Date shall apply to any Section of the Works (other than references to the Completion Date and Intended Completion Date for the whole of the Works).

3. Possession of Site

- 3.1 The Procuring Entity shall give possession of all or parts of the Site to the Contractor based on the schedule of delivery indicated in the SCC, which corresponds to the execution of the Works. If the Contractor suffers delay or incurs cost from failure on the part of the Procuring Entity to give possession in accordance with the terms of this clause, the Procuring Entity's Representative shall give the Contractor a Contract Time Extension and certify such sum as fair to cover the cost incurred, which sum shall be paid by Procuring Entity.
 - 3.2 If possession of a portion is not given by the above date, the Procuring Entity will be deemed to have delayed the start of the relevant activities. The resulting adjustments in contract time to address such delay may be addressed through contract extension provided under Annex "E" of the 2016 revised IRR of RA No. 9184.

4. The Contractor's Obligations

The Contractor shall employ the key personnel named in the Schedule of Key Personnel indicating their designation, in accordance with **ITB** Clause 10.3 and specified in the **BDS**, to carry out the supervision of the Works.

The Procuring Entity will approve any proposed replacement of key personnel only if their relevant qualifications and abilities are equal to or better than those of the personnel listed in the Schedule.

5. Performance Security

- 5.1. Within ten (10) calendar days from receipt of the Notice of Award from the Procuring Entity but in no case later than the signing of the contract by both parties, the successful Bidder shall furnish the performance security in any of the forms prescribed in Section 39 of the 2016 revised IRR.
- 5.2. The Contractor, by entering into the Contract with the Procuring Entity, acknowledges the right of the Procuring Entity to institute action pursuant to RA No. 3688 against any subcontractor be they an individual, firm, partnership, corporation, or association supplying the Contractor with labor, materials and/or equipment for the performance of this Contract.

6. Site Investigation Reports

The Contractor, in preparing the Bid, shall rely on any Site Investigation Reports referred to in the SCC supplemented by any information obtained by the Contractor.

7. Warranty

- 7.1. In case the Contractor fails to undertake the repair works under Section 62.2.2 of the 2016 revised IRR, the Procuring Entity shall forfeit its performance security, subject its property(ies) to attachment or garnishment proceedings, and perpetually disqualify it from participating in any public bidding. All payables of the GOP in his favor shall be offset to recover the costs.
- 7.2. The warranty against Structural Defects/Failures, except that occasioned-on force majeure, shall cover the period from the date of issuance of the Certificate of Final Acceptance by the Procuring Entity. Specific duration of the warranty is found in the **SCC**.

8. Liability of the Contractor

Subject to additional provisions, if any, set forth in the SCC, the Contractor's liability under this Contract shall be as provided by the laws of the Republic of the Philippines.

If the Contractor is a joint venture, all partners to the joint venture shall be jointly and severally liable to the Procuring Entity.

9. Termination for Other Causes

Contract termination shall be initiated in case it is determined *prima facie* by the Procuring Entity that the Contractor has engaged, before, or during the implementation of the contract, in unlawful deeds and behaviors relative to contract acquisition and implementation, such as, but not limited to corrupt, fraudulent, collusive, coercive, and obstructive practices as stated in **ITB** Clause 4.

10. Dayworks

Subject to the guidelines on Variation Order in Annex "E" of the 2016 revised IRR of RA No. 9184, and if applicable as indicated in the SCC, the Dayworks rates in the Contractor's Bid shall be used for small additional amounts of work only when the Procuring Entity's Representative has given written instructions in advance for additional work to be paid for in that way.

11. Program of Work

- 11.1. The Contractor shall submit to the Procuring Entity's Representative for approval the said Program of Work showing the general methods, arrangements, order, and timing for all the activities in the Works. The submissions of the Program of Work are indicated in the SCC.
- 11.2. The Contractor shall submit to the Procuring Entity's Representative for approval an updated Program of Work at intervals no longer than the period stated in the SCC. If the Contractor does not submit an updated Program of Work within this period, the Procuring Entity's Representative may withhold the amount stated in the SCC from the next payment certificate and continue to withhold this amount until the next payment after the date on which the overdue Program of Work has been submitted.

12. Instructions, Inspections and Audits

The Contractor shall permit the GOP or the Procuring Entity to inspect the Contractor's accounts and records relating to the performance of the Contractor and to have them audited by auditors of the GOP or the Procuring Entity, as may be required.

13. Advance Payment

The Procuring Entity shall, upon a written request of the Contractor which shall be submitted as a Contract document, make an advance payment to the Contractor in an amount not exceeding fifteen percent (15%) of the total contract price, to be made in lump sum, or at the most two installments according to a schedule specified in the SCC, subject to the requirements in Annex "E" of the 2016 revised IRR of RA No. 9184.

14. Progress Payments

The Contractor may submit a request for payment for Work accomplished. Such requests for payment shall be verified and certified by the Procuring Entity's Representative/Project Engineer. Except as otherwise stipulated in the SCC, materials and equipment delivered on the site but not completely put in place shall not be included for payment.

15. Operating and Maintenance Manuals

- 15.1. If required, the Contractor will provide "as built" Drawings and/or operating and maintenance manuals as specified in the **SCC**.
- 15.2. If the Contractor does not provide the Drawings and/or manuals by the dates stated above, or they do not receive the Procuring Entity's Representative's approval, the Procuring Entity's Representative may withhold the amount stated in the **SCC** from payments due to the Contractor.

ROOF TRUSSES DIAGRAM








GENERAL PROVISIONS

The contractor/implementer of the project shall verify all dimensions and conditions of the site and shall notify the DA Project Engineer for any discrepancies between actual conditions and information shown in the drawing before proceeding with the work.

The structural drawings and specifications represent the general framework of the structure. They do not indicate methods of construction, unless so stated, the contractor/implementer shall provide all necessary measures to protect the structure, the contractor/ implementer's obligation to notify the DA Project Engineer of any conditions that may endanger the stability or cause distress in the structure during phases of construction.

This set of specifications shall govern the methods of construction and kinds of materials to be used for the proposed Project shown on the accompanying plans and detailed drawings.

All parts of the construction shall be finished with first class workmanship to the fullest talent and meaning of plans and the specifications, and to the satisfaction of the Department of Agriculture through its Project Engineer. Any defective material or poor workmanship should be replaced or improved by the contractor without additional cost to the owner.

All other materials specifically indicated and illustrated on plans shall be taken as part of this specification regardless whether or not written and such other materials shall be approved by the owner before they are set in place.

DESCRIPTION

GENERAL REQUIREMENTS (PROJECT BILLBOARD, PERMIT AND CLEA)

- The contractor shall be responsible for securing all necessary permits related to the project, which shall include but not limited to CNC, building permits, occupancy permit, etc.).
- All related documents shall be submitted to the End User.
- The contractor is responsible to secure and obtain information from the regulatory agencies in municipality for all and any other required permits not listed below. A copy of the required permits shall be submitted to the end user within 24 hours of obtaining such permits.

- Electrical permit and plans (if required by Building Official), is the contractor's responsibility.
- Health department approval and septic connections, contractor's responsibility.
 Contractor is required to check with the department to obtain information on the required plans and permits, if any.
- The new billboard design layout and dimension shall be install on a standard billboard, measuring 1200mm x 2440mm (4' x 8') using 12mm (1/2 inch) thick marine plywood or tarpaulin posted on 5mm (3/16 inch) marine plywood.
- For each building project, the billboard shall be installed in front of the project site.

II. CONSTRUCTION OF TEMPORARY FACILITY

- The contractor shall install/construct temporary facilities to expeditiously execute the work and shall remove them from the site when no longer required.
- The contractor shall obtain temporary and maintain in good condition a supply of potable water for construction use.
- The contractor shall install temporary electric services with sufficient capacity to supply proper current for various types of construction tools, motors, welding machines, pumps, testing, and other work required.

III. PROVISION OF SAFETY AND HEALTH

The Contractor shall ensure that every person working on or visiting the site, as well as the
public in general, shall be made aware of the dangers/hazards likely to arise from site
activities, including the precautionary measures to be taken to avoid or minimize those risk
associated to those dangers/hazards.

IV. MOBILIZATION AND DEMOBILIZATION

 The Contractor shall provide all labor and equipment costs necessary to move personnel, equipment, supplies and incidentals to and from the Project Site, establish offices, buildings, and other facilities necessary for the Work, obtain bonds, required insurance and any other pre-construction expenses necessary to perform the Work. This section shall exclude the cost of construction materials.

V. EARTHWORKS

A. EXCAVATION

- The work under this shall include clearing removal, hauling and disposal of all excavated materials tamping and trimming of foundation bed required for the construction of canal foundation.
- Foundations shall be excavated according to the outline of the footings and floors of structure as shown on the Drawings or as directed by the DA Project Engineer.

B. STRUCTURAL BACKFILL

All horizontal and sloped earth surfaces shown in the drawings or specified by the DA
Project Engineer, upon which backfill material is to be placed shall consist of undisturbed
or well compacted material and shall be clean, damp, free from water and free from organic
matter.

VI. CONCRETE WORKS (CLASS "A")

 This covers all the materials as cement, aggregates, water, admixtures and proportioning, mixing, transporting, placing, finishing, curing and protecting of concrete, including supplies, equipment, tools, and all other incidentals necessary for concrete works. It shall be a concrete mixture.

VII. RSB WORKS

- All reinforcement shall be placed in accordance with plans furnished by the Engineer. In case of any doubt or ambiguity in placing of steel, the Contractor shall consult the Engineer whose decision shall be final in such cases.
- All reinforcing steel bars used shall be new and free from rust, oil, defects, grease or links.
 All loose rust or scale, adhering materials and all oil or either materials which tend to destroy bond between the concrete and the reinforcement shall be removed before placing the steel and before concreting begins.
- Metal reinforcement shall be accurately placed and adequately secured by concrete or metal chair spacers. The minimum distance between the parallel bars shall be one and onehalf times the diameter for round bars and twice the side dimensions for square bars. In no case shall the clear distance between bars shall be less one or more than one and one-third times the minimum size of the coarse aggregates. Where bars are used in two or more layers, the bars in the upper layers at distance of not less than one inch.
- All steel reinforcing bars shall be accurately placed and secured against displacement by tying them together at each bar intersection with Gauge No. 16 galvanized iron wire.
- All main reinforcing steel used in the structure shall conform to ASTM Grade 40 (Intermediate Grade) with yield strength of 40 ksi (276 MPa).
- All temperature bars shall conform to ASTM Grade 30 Structural Grade with minimum yield strength of 30 ksi (207 MPa).
- Always apply red oxide for the exposed RSB to eliminate from rusting.

VIII. FORM WORKS

Forms shall be used whenever necessary to confine the concrete during vibration and
to shape it to the required lines. Forms shall have sufficient strength to withstand the
pressure resulting from placement and vibration of the concrete and shall be
maintained rigidly in position. The strength and rigidity of the forms shall be such that
formed surfaces will conform to specification requirements relating to the surfaces
irregularities and tolerances for concrete construction. Forms shall be tight to prevent
loss of mortar from concrete.

IX. MASONRY WORKS

 The cells of the concrete hollow blocks to be laid shall be filled with 1:3 cement mortars (1 part Portland cement and three parts sand, by volume). They shall be reinforced with 10mm diameter horizontal deformed bars every three blocks and 10mm diameter vertical bars deformed bars at 400mm O.C. Unless specified on the elevation drawing, the cement plaster mixture for masonry walls shall be 1:3 (1-part cement, and 3 parts sand, by volume).

Minimum Compressive Strength of Concrete Hollow Blocks is as follows:

Class A Class B 900 psi 750 psi

 Held in place by horizontal and vertical reinforcing and interior surfaces of hollow blocks shall be thoroughly soaked with water before laying. Hold all units in storage for a period

- not less than 28 days (including curing period) and do not deliver prior to that time unless strength and other tests indicate compliance with these specifications.
- Mortar aggregates shall be natural river sand, clean and free from soluble slats and
 organic matter, graded from fine to coarse, compatible with the thickness of joints in
 which used. Mix mortar from three to five minutes in such quantities as are needed for
 immediate use.
- 4. Lay units in common bond with uniform causing and jointing. All concrete block jointing shall be of uniform thickness. Butler vertical and horizontal jointing full with mortar. Bond course and corners and intersections and tie to abutting walls. Do not lay cracked, broken or deface blocks. Cut edges shall be clean and sharp. The first row of block shall be properly and thoroughly anchored to the concrete columns, walls of slabs. Course shall be laid straight and well plumbed.

X. PLASTERING WORKS

The Plastering of CHB wall should be 20mm thick using Portland Cement and sand. The mixture ratio should be (1:2) and must be smooth finish free from debris.

XI. STEEL WORKS

- The fabrication and erection shall be done to conform to AISC Specification and TOTAL Steel System Technical Manual Pre-Engineered Buildings. The Contractor generally has to make or provide shop drawings, which are to be used in actual construction. These shop or working drawings are to be approved by the Architect / Engineer before implementation. The approval of any shop or working drawings, shall not in any way deemed to release the Contractor from full responsibility for complete and accurate performance of the work in accordance with the Contract Drawings and Specifications; neither shall such approval release the Contractor from any liability placed upon him in the Contract.
- This specification shall only apply to members specifically designated on the design drawing as "architecturally exposed structural steel" which shall be fabricate and handled and erected as directed in this specifications, and except as noted in conformity with the American Institute of Steel Construction Specification for the design. Fabrication and erection of Structural Steel for Buildings. All fabrication tolerance of the code of the standard practice.
- Materials shall be the same as specified for Structural Steel by AISC Specification.
- Overall profile dimensions of built-up members shall be adequate to provide for the accumulated permissible overrun of the component parts.
- Fabrication shall be performed with special care and necessary straightening to maintain the condition of the material as described above.
- Shop details, shall show clearly the required fabrication tolerances. Erection plans and/or anchor bolt plans shall show the required tolerances for setting embedded items.
- All copes, miters and butt cuts in surfaces exposed to view shall be made with uniform gaps of 1/8" if shown by the Architect to be open joints, or in uniform contact if shown without gap.
- Where the fit-up of adjacent members is such that permissible tolerances specified in Sections 2b and 2c may result in unsightly joint, the Architect shall specify on the design

plans tolerances required. This tolerances shall be maintained by special attention in detailing the joint, or if necessary by refined fabrication techniques.

- Faces of welds exposed to view shall have as welded surfaces that are reasonably smooth and uniform. No finishing or grinding shall be required except where clearances or fit of other items may so necessitate, or as specifically required by design drawings.
- Butt and plug welds exposed to view shall have as welded surfaces that are reasonably smooth and uniform and shall not project more 1/6" above the surfaces joined. No finishing or grinding shall be required except where clearances or fit of other items may so necessitate, or as specially required by design drawings.
- After inspection and approval and before leaving the shop, all steel works shall be cleaned by hand wire brushing, or by other means, erected by fabricator, or loose mill scale, loose rust, accessible weld slag on flux deposit, dirt and other foreign matter. Oil and grease deposits shall be removed by solvent.
- After cleaning all steel works shall be given one coat of shop paint applied thoroughly
 and evenly to dry surfaces, by rush, spray, roller coating, flow coating or dripping, at the
 selection of the fabricator.
- Surfaces within two inches of any field weld location shall be free of materials that
 would prevent proper welding or produce objectionable fumes while welding is being
 done. If shop painted surfaces to be welded shall be wire brushed in the field before
 welding to reduce the paint film to a minimum.
- The erection shall use special care in unloading, handling and erecting the steel to avoid bending, twisting or otherwise distorting the steel members. The erector shall handle the material in such a way as to minimize the damage to shop coat paint.
- The erector plans and executes the erection in such a way that the close fit and meets appearance of the joints and the structure as a whole will not be impaired.
- If temporary braces or erection clips re-employed, care shall be taken to avoid any
 unsightliness upon removal. Tacks welds shall be ground smooth and holes shall be
 filled with weld metal or body solder and smoothed by grinding or filling.

XII. TINSMITHRY WORKS

- All materials shall be installed in accordance with the plans or unless otherwise specified
 by the Engineer. Care shall be exercised in storing, handling, and to prevent any damage to
 roofing siding sheets. The sheets shall be of the length indicated of the plan, or greatest
 length suits the purlins. Extreme cares shall be exercised in drilling pilot holes for fastening
 centered in valleys or crowns as applicable. All metal shaving shall be swept from roofs in
 competition to prevent rusting and discoloration.
- The roof used is GA 26 pre-painted Rib-type GI sheet. All sheets to be supported at both ends, at the middle end laps to be properly secured.
- Ridge rolls and hip rolls to be used shall be compatible with the Rib-type roofing with a
 thickness of 0.5mm. They shall be lap the roofing sheets at least 25 cm. The ridge roll and
 hip rolls shall be riveted to the roofing sheets, in addition to the rivets engaging the GI
 straps in securing the roofing sheets to the purlins.

XIII. DOORS (INCLUDING INSTALLATION)

Roll- up door with complete set of accessories.

XIV. PAINTING WORKS

All painting works for this project, except as hereinafter specified, shall be done with the use of paint products.

The contractor shall supply all labor, paint materials, tools, staging and equipment necessary, and shall perform all painting and finishing work as shown in the schedule of painting and finishing work for this project. The painting contractor shall store his materials in one place in the building to be kept near and clean, care being taken in the storage of paints, oils, etc. to prevent danger of fire. Oil rags shall be kept in metal containers and shall be removed from the building every end of the working day. All paintings are to be done in good workmanship manner. No painting shall be done on all surfaces before neutralizing and proper sand papering is through. No painting on damp weather is to be done.

All concrete surfaces to be painted shall first be coated with concrete neutralizer. Exterior walls shall be finished with Solvent-Based Acrylic Paint, first coated with Penetrating sealer. Interior wall shall be finished with Latex Paint, first Painted with concrete sealer. Steel or iron surfaces must first be painted with anti-rust proofing. All color schemes for painting the building shall be decided by the Architect and end user, to be implemented upon completion of the construction. The Contractor shall submit color samples and finishes for approval by the Architect and End user before final application.

Cracks and holes shall be filled with putty compatible with the surface to be painted and the paint materials to be applied. All wooden door jambs and cabinet frames and shelves to come in contact with masonry surfaces must be painted with SOLIGNUM wood preservative.

Upon completion of the painting works, the painting Contractor shall remove any paint spots from all finished work. He shall present his work to the in charge of the Construction, free from blemishes and rubbish generated by his workers.

Before any painting is done, all surfaces shall be cleaned, smoothed and freed from dust, dirt, grease, mortar, rust and other foreign substances. All parts where paint remover has been used shall be washed off with paint or lacquer thinner. All paints shall be spread evenly and carefully.

All paint and paint materials shall be delivered to the building site in unbroken packages, bearing the marks of the specified brand. No adulteration of specified paints with other brands shall be allowed without the consent of the Architect and End user.

All other materials specifically indicated and illustrated on plans shall be taken as part of this specification regardless whether or not written and such other materials shall be approved by the end user before they are set in place.

XV. ELECTRICAL WORKS

The builder shall install all materials as indicated in the drawings and the necessary panel boards or circuit breakers. Install all equipment and materials in a neat and professional manner. Leave all exposed parts of the electrical works in a neat, clean and usable condition, with painted surfaces unblemished and polished surfaces re polished. Panel boards to be used shall be flush mounted when located in areas that are visible.

All electrical works for the building will be done in accordance with the provisions of the Latest Philippine National Electric Code and the rules and regulations of the Electrical Ordinance of the Municipality, and rules and regulations of other governing authorities.

All works shall follow the pertinent provisions of the latest edition Philippine Electrical Code and its respective implementing rules and regulations together with requirement of the local power company.

The work shall be of the highest quality and accordance with the latest standards of engineering practices

The work shall be under the responsible charge of/or supervision of a duly licensed Electrical Engineer or a Master Electrician in conformity with the field of competence of each grade.

Data presented on this plan are as accurate as preliminary survey that planning can determined, but accuracy is guaranteed and field verification of all dimension is directed of the actual execution of the work this plan is for guidance and assistance, but the levels will be governed by field condition.

Where field condition requires deviations from plan, all suggested the supervising authorities to avoid unnecessary conflict with other trade should first check change.
